#### ARTICLE VI. TERM OF OFFICE OF BOARD OF DIRECTORS

\*Reads: "At the annual meeting of the general membership following the adoption of these By-Laws, ten (10) persons will be nominated and elected Recommended Changes: Following the adoption of these By-Laws, the Board of Director members shall be elected for staggered terms, with approximately 50% of the membership expiring each year.

The Board may request removal of a Board member who has 3 consecutive unexcused absences from scheduled Board meetings. A majority vote by the board is required for the Secretary to submit a written removal letter to the member.

#### Page 3 ARTICLE VII. ELECTIONS

Reads: Section 3. A treasurer shall be selected by the Board of Directors, and such person need not be a member of the Senior Citizens Council.

Recommended Change: ...and such person must be a member of the Senior Citizens Council.

#### ARTICLE VIII. DUTIES OF OFFICERS

\*Reads: Section 4. Treasurer. The Treasurer shall receive all funds of the Senior Citizens Council and deposit same in a bank designated by the Board of Directors. Further, the Treasurer shall disburse all funds as instructed by the Board of Directors....

Recommended Changes: The Treasurer, President and/or a designated Board Member shall receive all funds of the Senior Citizens Council and deposit same in a bank designated by the Board of Directors. Further, the Treasurer, and/or President shall disburse all funds as instructed by the Board of Directors.....

Purchases in excess of \$100, excluding those for wages, transportation and luncheon food, require a majority vote of the Board during a regular or special session.

The Board shall appoint a Board member, independent of financial responsibilities, to perform a quarterly audit of the banking transactions.

#### Page 4 ARTICLE X. AMENDMENTS TO BY-LAWS

Reads: .... proposed amendments shall have been published in the senior newsletter or posted on the Senior Citizens bulletin board at Emanuel Fellowship Hall for two (2) weeks prior to the time of voting.

Recommended Changes: proposed amendments shall have been published in the senior newsletter or posted during the senior meals for two (2) meals prior to the time of voting.
